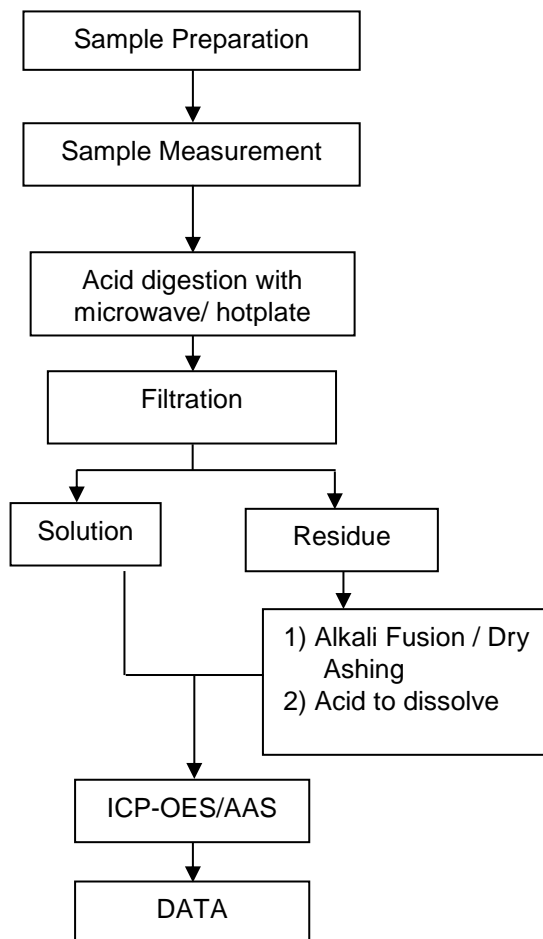

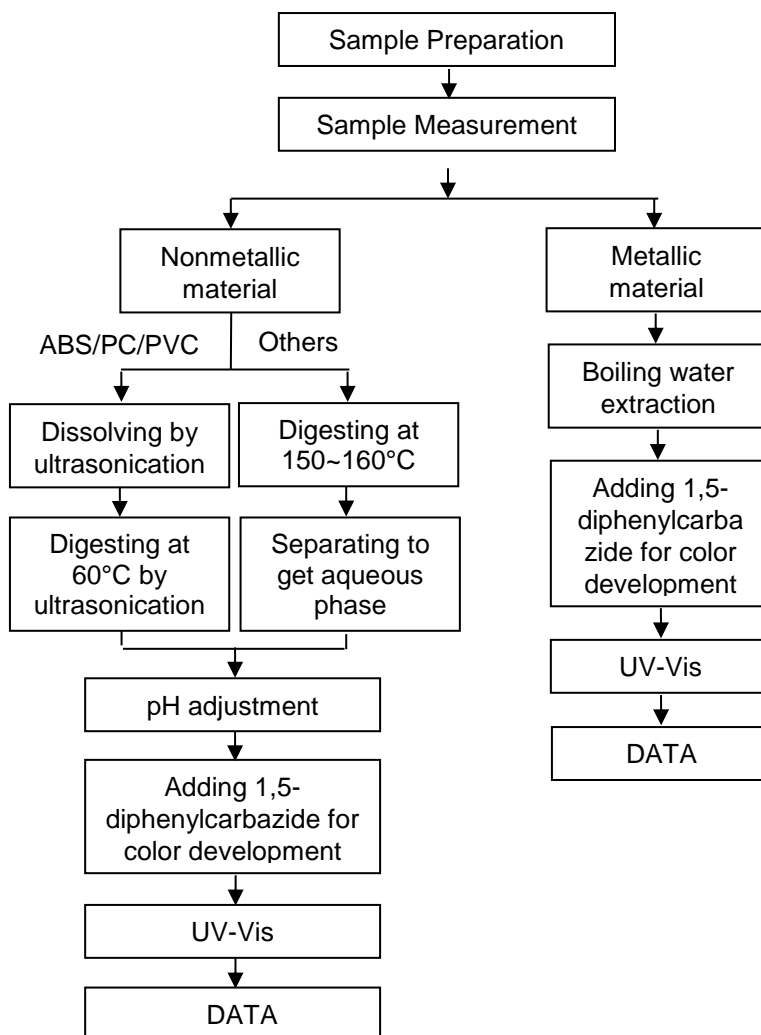

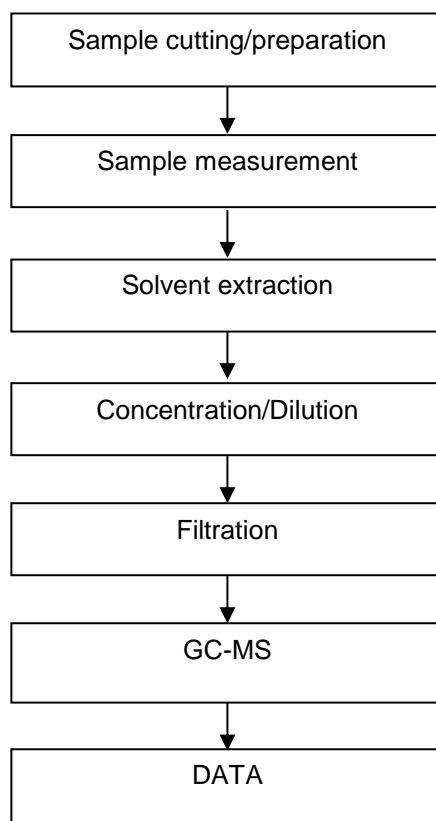

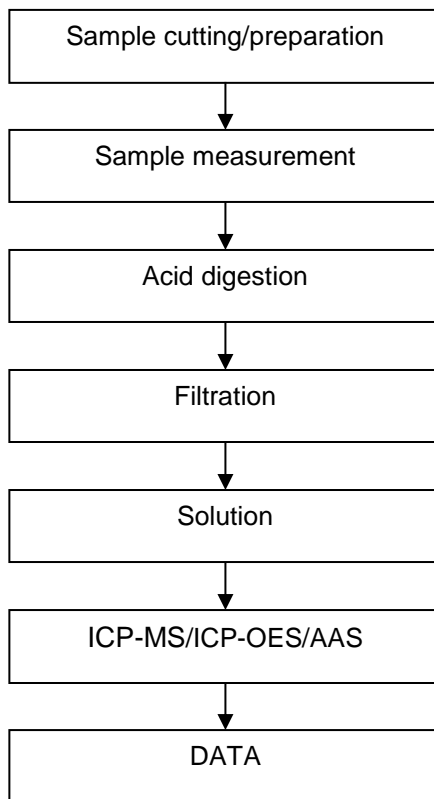

Elements Testing Flow Chart



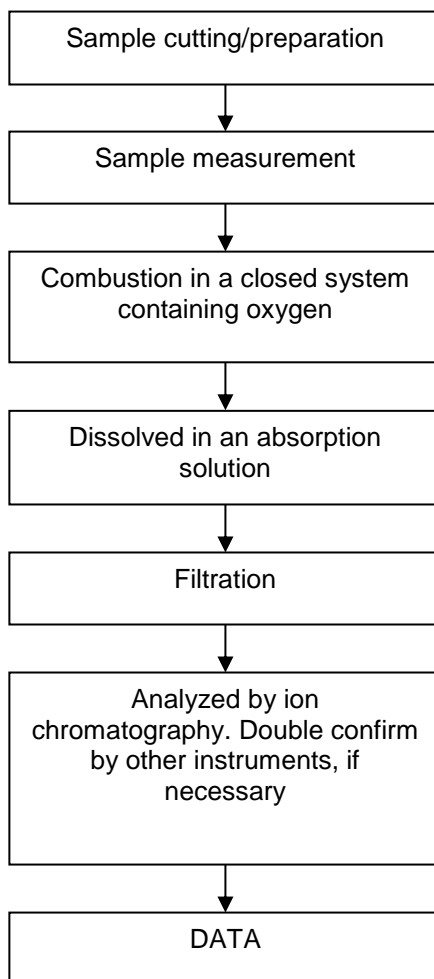
